		consideration which was agreed by the Committee.

		they will hold some reffing clinics to support referees.

	Team Organisers – Pat was proposed for the ladies. All in favour. Kevin proposed Tim for Pirate's coordinator. Stef seconded and all were in favour. It was agreed that Team Organisers should also organise the reffing rota for their team. Tournaments Point of Contact – It was agreed that this role should be joined with that of Website Coordinator. Steve proposed Mano. Kevin seconded. All in favour. Player Liaison Officer – Stef proposed Lisa. All in favour. Everybody agreed we should have a Social/Events Secretary – Stef proposed Fran. Lisa seconded. All in favour.
Fee structure Review	Our Fee is calculated on the basis of how may training
	sessions we have scheduled with SMS. That gives players access to all training sessions for that year. For people joining mid-season, a pro rata calculation may be considered by the Committee. There will be 36 training sessions this coming year (2015/16) between September and end of June (excluding holidays and dates when SMS is not available). It was proposed that the yearly membership fee should remain £200 for this year. 7 voted in favour and 1 against. It was agreed that for new joiners the first session will be free. They are then entitled to 2 subsequent sessions charged at £7 per session before they need to decide whether to join the club. Should they join, the £14 they have paid will be deducted from the total fee. All members will need to register again in September so that we can get an accurate list of all club members. Match fees stay at £36 per match which need to be collected by the team organisers or a delegate at each
Team Entries for 2015-2016 season	match. We will enter a Pirates team and a Vixens team. Stef to check the HVA website to find out how to enter
	the teams.
Training	Venue SMS will continue to be our training venue. Net quality and safety – net and handle on the posts needs to be replaced. Steve to write a letter to SMS requesting this and also asking about the 2 balls lodged in the ceiling and whether a broom can be made available to clean the floor. Pat and Tim to assess the net/post equipment we have and agree what needs replacing and make a recommendation to the committee. Session format Session format Session format for the 2015/16 season will be as follows: 7-7:50 free play 7:50 whistle blow and stretching/warm up starts 8-9 – drills and skills 9-9:30 match play for all members 9:30-10 squad-focused play There will be occasional game play on Fridays when there is no match at the weekend – Stef to work out when that will be once the fixtures for the new season are agreed. New members should be made aware when joining that between 7 and 7:50 it will be free play.

Coaching Trevor has fed back that he thinks coaching for just 1 hour is not long enough and he also got the impression that some members were not interested in structured drills. He is happy to continue running our training sessions but we have to be very clear what we want to get out of them and we should aim to give him a prescriptive list of things we want to focus on. Phil has also volunteered to run some training sessions on an adhoc basis (he is not available every week) although this is very welcome, it was agreed that given Trevor is available to do this on a regular basis for the whole season, this would be a better option for the club and the squads. Kevin and Fran are both interested in coaching. We will apply for HVA funds for this or the club will pay. We should also offer this to Trevor. **Stef** to find out from the HVA how we apply for funds for the coaching course. Kevin to respond to Trevor and accept his offer of coaching for next season. We are also offering to pay 45p per mile for his commute. **Kevin** to organise a present for Trevor to recognise the effort he put in last season into coaching us. 10. AOB Website - it was agreed that we need to revitalise our online presence in order to attract new people to the club. This does not necessarily mean having our own website – we could just use the facebook page. Mano to think of options of what could be done and potentially quotes for somebody to revamp our website. Stef to work out how to change the external PoC on the HVA and EVA sites to Stef rather than Phil. Fran to set up generic email accounts for all Committee members. Junior volleyball – Fran to explore the possibility of running a junior session/event potentially in the second part of the year. Sitting volleyball - we have all the kit to organise some sitting volleyball events. Potentially, one of our training sessions towards the end of the year could be a sitting volleyball event. **Equipment** – a number of people took equipment away at the end of the season. Stef to email all and collate a list of who has what. Tim – to check with Chris if he has the Pirates away bag/medical kit. Children – Stef to email the EVA and find out whether our liability insurance covers child spectators at sessions. In the meantime, respond to Marta saying we will speak to EVA regarding the club position on children attending training and matches. Stef to draft a welcome email containing core details for joining the club and circulate to the Committee for review.
